You are receiving this notice because you have expressed past interest in Conejo Creek West and Northwest Parks.

Our staff held community meetings in September 2025 to gather public input; and are continuing the process with additional community meetings. Due to the feedback to date, we are concentrating efforts towards Conejo Creek West Park, and will not further evaluate Conejo Creek Northwest Park.

This assessment of the park facilities, with comprehensive input from the public, will allow CRPD to evaluate the community's needs and determine whether new or renovated amenities are required to meet those needs. At the meetings, we will discuss the process to date, including feedback received, the guiding principles and the initial concept plan generated from the first round of community input, and the future steps of the assessment. The District seeks your ideas, input, and feedback.

These meetings are for long-range planning purposes to further understand the community's needs and interests at the park sites; any potential improvement is currently unfunded for construction. However, CRPD is conducting this public outreach in preparation for potential future available funds.
