*Target: 503 Units



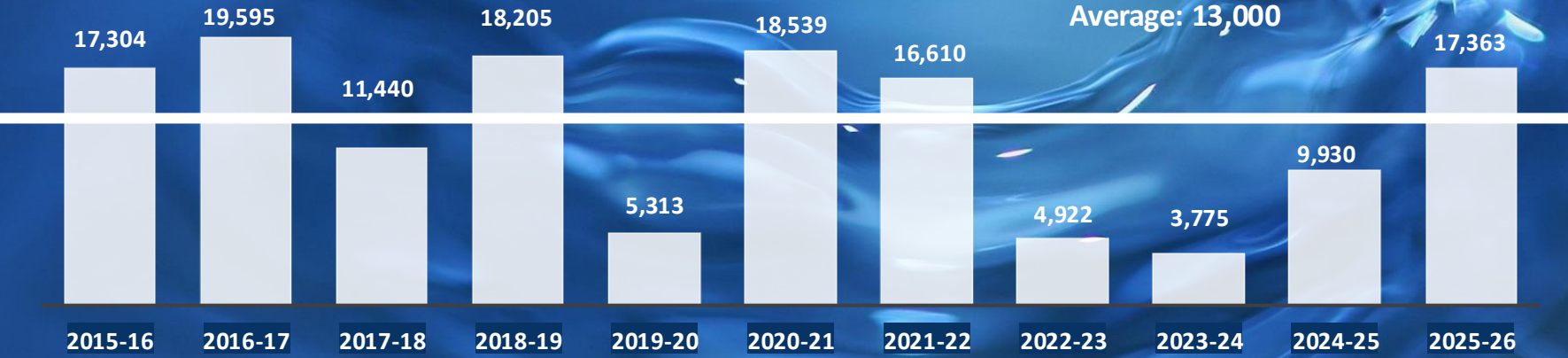
