#### INTRODUCTION

As a result of neighborhood meetings conducted in May 2014 at Kimber Park, Walnut Grove Park, and Estella Park, and to address the concerns (generally regarding potential increased traffic, noise, and attendance) of the local residents of future potential Off-Leash Areas, the Conejo Recreation and Park District (District) performed site studies at all three parks.

These studies were conducted over a 13-hour period, from 7:00 a.m. to 8:00 p.m., on the Tuesday, Thursday, and Saturday of one week per park – a baseline study in the Summer of 2014 and a comparative study during the Summer of 2015. The baseline study was conducted prior to the implementation of the installation (which occurred in March 2015) of Temporary Off-Leash Areas at each park; the comparative study was conducted after the installation of the Temporary Off-Leash Areas.

For traffic, as recommended by the City of Thousand Oaks traffic division, the standard interval of 15 minutes of recording was employed.

Noise (Sound) levels were recorded by measuring sound in decibels three times per day at low, ambient, and high levels. For each recording, the District representative circled the park and read and recorded the meter at various locations. For further explanation and information on the sound recording methods, please see the "*Definitions and References*" on the next page.

Park attendance was also recorded. Two categories were made: one for patrons with dogs, the other for patrons without dogs. It should be noted that the patrons, not the dogs, were counted. Two patrons with one dog between them were each counted as a patron with a dog. Furthermore, one patron with multiple dogs was still only counted as one patron with a dog. This, however, was a rare occasion and such instances were in the minority.

In the Data Appendix, raw data from the 2014 site studies is displayed alongside the data collected from the 2015 site studies. For easier comparison, the data is graphically presented in exhibits throughout this report.

The efforts of patrons cleaning up their dog's waste was observed and recorded at each park.

#### DEFINITIONS AND REFERENCES

- 1. **dBA** Decibels recorded in a filter in which low and very high frequencies are given less weight than on the standard decibel scale. It was used in this study for its similarity to human sound recognition.
- 2. **High dBA** The highest noise level the meter recorded.
- 3. Low dBA The lowest noise level the meter recorded.
- 4. **Ambient dBA** This recording includes all sounds present in the environment. It is often viewed as the "background noise level."
- 5. Average Sound Recording Average of low, ambient, and high recordings of morning, noon, and evening
- 6. **Morning** Recordings taken in the morning were taken between 7:00 a.m. and 9:00 a.m.
- 7. **Noon** Recordings taken at noon were taken between and 11:00 a.m. and 12:00 p.m.
- 8. **Evening** Recordings taken in the evening were taken between 6:00 p.m. and 8:00 p.m.
- Check Mate SPL Meter This meter was used to record the sound levels. Its serial number is 060707268.
- 10. **Park-Car Traffic** Cars parked at the park were counted. For Kimber Park, all cars were counted if they were on Wendy Drive along the park, on Bear Creek Road along or across the street from the park, or in the parking lot. For Walnut Grove Park, for both Windtree Avenue and Newbury Road, all cars along or across the street from the park were counted. For Estella, only cars in the lot were counted.
- 11. **Temporary Off-Leash Areas** Small (½ to ¾ acre) areas were temporarily fencedoff with chain link at each park. Unlike the existing main dog park at Conejo Creek West, due to its small area, there is no division between small and large dogs. The Temporary Off-Leash Areas were provided with double gates, mutt mitt dispensers, receptacles, and other basic necessities.

Most noise levels are given in <u>dBA</u>, which are decibels adjusted to reflect the ear's response to different frequencies of sound. Sudden, brief impulse sounds, like many of those shown at 120 dB or greater, are often given in dB (no adjustment).

#### KIMBER PARK

Baseline Study - July 15, 17, and 19, 2014 Comparative Study - July 7, 9, and 11, 2015

#### A. DESCRIPTION

Kimber Park is located at 3295 Bear Creek Drive, Newbury Park, California 91320. It is bordered by Wendy Drive and Bear Creek Road. With a total of 8.3 acres, Kimber Park has 6 barbecue grills, a drinking fountain, a 0.4 mile fitness trail, 6 picnic tables, a playground, a volleyball court, and 12 parking stalls. Kimber Park's large surface area allows for many visitors and a variety of activities. For example, soccer, ultimate frisbee, basketball, and bean bag toss all took place during the site study period. Multiple pick-up sporting events were played on Saturday.

#### B. TEMPORARY OFF-LEASH AREA DESCRIPTION

The approximate ½ acre off-leash area at Kimber Park is isolated into a far corner of the park. A sidewalk from the parking area separates the main park acreage from the off-leash area. (See map on page 51).

#### C. CAR TRAFFIC

Every fifteen minutes, the representative counted the parked cars on Bear Creek and the parking lot. It should be noted that some cars were present all day on Bear Creek and did not move. These cars were assumed residents of the area and were not counted towards the total amount of cars.

The 2015 study, as compared to the 2014 study, shows similar patterns and numbers for Kimber Park Car Traffic. On Tuesday and Thursday, around 5:00 p.m., the amount of cars spiked, and Saturdays had many cars present at midday.








#### D. SOUND


The sound recordings were conducted three times per day: morning, noon, and evening. They were not exact times because that gave the District representative the flexibility to successfully count all cars and park visitors before measuring the sound levels. Each time the District representative measured the sound levels, he walked around the park, and three recordings were made. The recordings were taken at different locations throughout the park to ensure diverse and accurate data readings.


The 2015 study, as compared to the 2014 study, shows similar patterns and numbers for Kimber Park sound levels. It should be noted that most of the highs came from loud, passing cars, and none came from barking dogs.

































#### E. ATTENDANCE

Attendance recordings were taken every fifteen minutes from the Kimber Park shade structure, allowing for the recording of every patron that entered the park. Additionally, it was noted whether or not they were patrons with dogs.

The 2015 study, as compared to the 2014 study, shows a significant increase in patrons with dogs on all three days, which can be attributed to the existence of the Temporary Off-Leash Area. In the 2015 study, there was a significant increase in patrons without dogs on Thursday and Saturday and most were children and young adults playing pick-up game activities. Despite these increased numbers, the park never at one time exceeded the carrying capacity (137) of the park. The people were dispersed throughout the day.

For both years, children were a large portion of patrons without dogs; however, patrons with dogs consisted mostly of adults.



### F. CLEANLINESS

During both the 2015 and 2014 site surveys, the CRPD representative observed dog waste management by the patrons. In both years, approximately 90% of the patrons picked up after his or her dog.

#### WALNUT GROVE PARK

#### Baseline Study - July 22, 24, and 26, 2014 Comparative Study - July 14, 16, and 18, 2015

#### A. PARK DESCRIPTION

Walnut Grove Park is located between the 101 Freeway and Newbury Road. It is located at 400 Windtree Avenue Thousand Oaks, California, 91360. With a total of 6.5 acres, Walnut Grove Park has a backstop, 3 barbecue grills, a drinking fountain, a 0.7 mile fitness trail, a handball court, an outdoor basketball court, 4 picnic tables, a playground, and approximately 30 parking spaces along the frontage on Windtree Avenue.

#### B. TEMPORARY OFF-LEASH AREA DESCRIPTION

The approximate <sup>3</sup>/<sub>4</sub> acre size of the off-leash area really benefited larger dogs who visited, as they had more room to run and play. The off-leash are is located on the northwest corner of the park, up against the freeway (see map on page 52). The location of the off-leash area along the freeway keeps the rest of the park appearing spacious and open to the public for use.

#### C. CAR TRAFFIC

With only one street to monitor, the District representative stayed at the bench or table in the center of the park. It should be noted that several cars were parked upon his arrival, and for the most part, remained there all day and thus not counted. Only cars with patrons that stepped foot on the actual park were counted.

The 2015 study, as compared to the 2014 study, is nearly identical, with the exception of Saturday 2015, as numbers significantly decreased due to heavy rains. On Tuesday and Thursday of both years, car traffic spiked significantly due to pick-up soccer games. The park sits along 700' of Windtree Avenue, so parking never appeared too cluttered or overcrowded. There was plenty of space for everyone to park comfortably, even during the late weekday spikes of traffic.








#### D. WALNUT GROVE PARK SOUND


Sound tests were conducted at morning, noon, and evening. The District representative circled the park and tested for the low, ambient, and high sound levels. Walnut Grove Park is positioned directly beside a freeway. Therefore, its highs always came from loud cars on the freeway. The area of the fitness trail along the freeway produced sound levels nearly 10 dBA higher than the rest of the park. Again, most dogs did not bark. Some did, but it was short and not consistently loud.


The 2015 study, as compared to the 2014 study, shows similar patterns and numbers for Walnut Grove Park sound levels.
































#### E. ATTENDANCE


Attendance recordings were taken every fifteen minutes at Walnut Grove Park. Additionally, it was noted whether or not there were patrons with dogs.

The 2015 study, as compared to the 2014 study, shows an increase in patrons with dogs on all three days, which can be attributed to the existence of the Temporary Off-Leash Area.

In the 2015 study, there was an increase in patrons without dogs on Tuesday and Thursday and most were children and young adults playing pick-up game activities. Despite these increased numbers, the park never at one time exceeded the carrying capacity (103) of the park. The people were dispersed throughout the day.

In 2014, it should be noted that around 3:00 p.m. on weekdays, anywhere from 15-20 people with dogs gathered at the northwest corner (site of existing Temporary Off-Leash Area) of the park for anywhere from 1-2 hours. They all let the dogs off-leash.

In 2015, each morning when the District representative arrived, there was already at least one dog in the off-leash area. This off-leash area was the most consistently used out of all three parks. During the site survey, it seemed like the off-leash area was never empty with at least one dog present.



#### F. CLEANLINESS

During both the 2015 and 2014 site surveys, the CRPD representative observed dog waste management by the patrons. In both years, nearly 100% of the patrons picked up after his or her dog. In 2015, any waste left by patrons was confined to the Temporary Off-Leash Area.

#### ESTELLA PARK

Baseline Study - July 29, 31, and August 2, 2014 Comparative Study - July 21, 23, and August 1, 2015

#### A. DESCRIPTION

Estella Park, is located at 300 Erbes Road between Thousand Oaks Boulevard and Hillcrest Drive. Totaling 1.9 acres, Estella Park features a barbecue grill, and outdoor basketball court, 6 parking stalls, 2 picnic tables, a playground, a restroom, and a tennis court.


#### B. TEMPORARY OFF-LEASH AREA DESCRIPTION


The approximate ½ acre off-leash area at Estella Park is located at the front of the park, adjacent to Hillcrest Christian School. The terrain is uneven and mostly covered with dirt. (See map on page 53).


#### C. ESTELLA PARK-CAR TRAFFIC

Estella is a very small park, so the District representative conducted the test from the parking lot. The parking lot allowed the representative to see the park in its entirety. It should be noted, however, that several cars were parked upon his arrival, and for the most part, remained there all day. Thus, both in 2015 and 2014, it is assumed residents from the surrounding neighborhood leave their cars overnight (in violation of CRPD Ordinance Section 202), as at least three cars each day were parked there upon the District representative's arrival at 7:00 a.m. They were included in the final presentation of the data because they accounted more than half of the available parking stalls.

The 2015 study, as compared to the 2014 study, shows an increase in parked cars. Should the temporary off leash areas become a recreational amenity at this park, appropriate signage and enforcement should occur to ensure more available parking for patrons.










#### D. SOUND


The sound recordings were conducted three times per day: morning, noon, and evening. The recordings were taken along the perimeter of the park in order to cover the entire park, as well as to find any area that may have been remarkably louder or quieter than the rest of the park. Highs sometimes came from passing cars or, in 2014, from construction behind the park, but the entire park exhibited consistent sound levels. This is likely the result of its compact nature and proportions.


The 2015 study, as compared to the 2014 study, shows similar patterns and numbers for Estella Park sound levels.




















## E. ATTENDANCE

Attendance recordings were taken every fifteen minutes from the Estella Park parking lot, allowing for the recording of every patron that entered the park. Additionally, it was noted whether or not they were patrons with dogs.

In 2014, very few people attended this park, which could be attributed to major construction along Erbes Road.

The 2015 study, as compared to the 2014 study, shows a significant increase in patrons with dogs or without dogs on all three days, which can be attributed to the existence of the Temporary Off-Leash Area. Despite these increased numbers, the park never at one time exceeded the carrying capacity (57) of the park. The people were dispersed throughout the day.



Hi,

I would like to tell you about our wonderful off-leash area in the Kimber/Wendy Park. My dogs and I have been going to this area since it opened and it has changed so many things for us.

To begin with the benefits of good exercise have become a positive for all 3 of us. Before the OLA I would walk my dogs for an hour or more each day but it would never be enough and my dogs would always come home still full of energy. Now we can play for half an hour in the OLA, chasing balls and running with doggy friends and the dogs will come home exhausted. A half hour at the OLA as opposed to an hours walking the neighborhood has also meant that I now have time to work out, and am feeling the benefit of time spent on my cross-trainer or exercise bike. Walking is of course good for me but my dogs were never speedy so the exercise benefits to me were not great.

Socially, the OLA has made a huge difference. I have two rescue dogs; Bella is a 6 year old collie/pointer cross and Fay is a 3 year old collie/lab cross. Both dogs have sweet loving temperaments however Fay was very insecure and to begin with could sound and sometimes behave aggressively towards other dogs. She would never bite another dog but she would growl at dogs who came too close to her, the fur along her back raised. Going to the OLA was very stressful at first. I have never known her bite anyone or any other dog but I was always worried that this might change. The support of the other dog owners changed all that. We go to the OLA at a regular time each day and so we have gotten to know the other dogs and their owners. The other dog owners saw that Fay's behavior was all bravado and stemmed from her insecurities (she would always stay close to me and did not like dogs who came too close to either me or her). They encouraged me to stay in the park for an extra few minutes when Fay started to 'misbehave', and to step back and allow the dogs to work things out. Very gradually Fay's behavior started to change. Now I can go to the OLA without worrying. Fay plays with the other dogs, running up and down, chasing her ball. Now and again she will 'explain' to another dog that it is her ball, but there is no hint of aggression and I feel no concern about her behavior. In addition to this I can take her elsewhere and expect this improved behavior. We recently took the dogs to a dog beach.

This is one of Fay's favorite places in the whole world and she would always pull at her leash, barking uncontrollably to be allowed off to play. This time she walked calmly down the beach at my side until I was ready to let her off her leash. Again, other dogs on the beach were of no concern and our time on the beach was a joy. To really emphasize how important a change this I have to tell you that about 12 months ago I was considering having Fay re homed because her behavior was so stressful to me. I love both my dogs and the thought of re homing one is just not me at all, but even as she got older I could see no improvement in her behavior and was really beginning to despair. Today she is a different dog.

I have to say enormous thanks to the CRPD for opening our OLA and more importantly, to our 8am doggy friends: Henry, Lila, Sammy, Roxy, Rooby and new addition Lady, and also to our 8:30 friends (if we are running late): Annie, Kayla, & Bingo. Please keep the Kimber/Wendy OLA open.
