RE: Conejo Creek Southwest Park Development Project

Dear Tribal Representative:

In conformance with the tribal consultation requirements of [Assembly Bill \(AB\) 52](#), this letter is to inform you that the Conejo Recreation and Parks District is submitting the proposed project described below. Per AB 52, the tribe has the right to consult on a proposed public or private project prior to the release of a negative declaration, mitigated negative declaration, or environmental impact report. The project description is as follows:

The proposed Conejo Creek Southwest Park Development Project (project) consists of a park with a playground, multi-use court, sand volleyball court, fitness nodes, a picnic area, a backstop, a future corral, bike racks, fencing, a parking lot, a pedestrian path, a restroom, and multi-use lawns. Regionally, the proposed project site is located immediately west of State Route 23 and north of Highway 101 in the City of Thousand Oaks. Locally, the project is north of Combes Avenue, south of the existing Conejo Creek Channel, and bisected by Paige Lane on approximately 14.1 acres of vacant land, as shown in the attached figure.

Along the perimeter of the project site would be a Native Earth Equestrian Trail and pedestrian path. At the center of the project site would be a Chumash Creek themed playground, a single occupancy restroom, a parking lot, a picnic shade structure, a multi-use court, and a sand volleyball court. To the north and south of these facilities would be multi-use lawns, with a backstop on the north multi-use lawn. On the project site west of Paige Lane would be a multi-use lawn and a future corral.

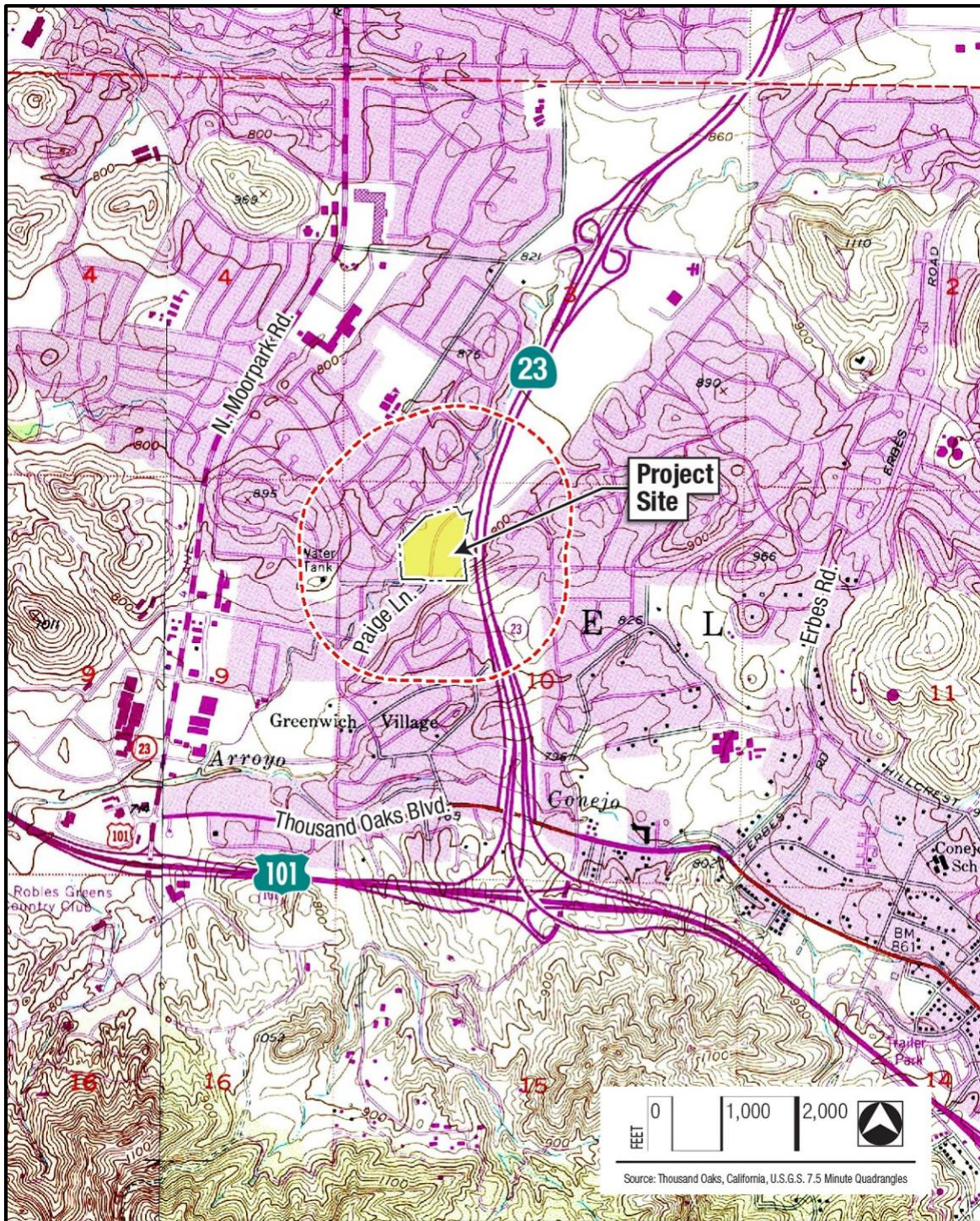
Project vicinity map on 1:24,000 topographic map
