Scertificate of Liability Insurance <u>and</u> Additional Insured Endorsement for your event must contain the following clause:

"This insurance is primary and non-contributory with any insurance carried by the certificate holder."

- Date of event or date range of coverage
- Location of event
- Name of Organization/Group/Business

Section al Insured Endorsement/Certificate Holder section must read:

Scancellation Clause must read as follows:

"Should any of the above described policies be cancelled before the expiration date thereof, the issuing company will mail 10 days" written notice to the certificate holder named to the left."

The Certificate of Insurance reads, *"This certificate is issued as a matter of information only and conflicts no rights upon the certificate holder. This certificate does not amend, extend or alter the coverage afforded by the policy."* Because of this language, an Additional Insured Endorsement **MUST** be included with the Certificate of Insurance.

Certificates of Insurance are prepared and signed by an insurance agent, <u>not the</u> <u>insurance company</u>. In most instances, they have no authority to bind the insurance company and in the event of a loss, the insurance company will fight any reimbursement stating they never agreed to add us as additionally insured.
