Job Description

Title: Senior Camp Counselor Status: Part-Time, Seasonal

Division: Recreation & Community Services **Job Grade:** 3

Position Summary:

Under general supervision, the Senior Camp Counselor provides leadership of activities and games for an assigned group of campers in accordance with District policies and procedures.

Essential Duties and Responsibilities:

- Organize campers, direct camp activities, and assist the Camp Director whenever possible
- Employ creative use of resources, individual abilities, and talents in the planning and scheduling of daily group activities such as adventure hikes, sports, games, songs, and crafts
- Direct and supervise camp volunteers
- > Implement inclusion accommodations as recommended by the Inclusion Coordinator
- > Promote individual camper success, safety consciousness, and appropriate camper behavior
- > Enforce emergency procedures, safety guidelines, and other camp rules
- > Assist in camp overnights, field trips, special events, and camp maintenance when applicable
- Senior Camp Counselors may work up to 45-55 hours per week

Other Duties and Responsibilities:

- May serve as the acting Camp Director in the event of an absence
- > Attend weekly staff meetings and staff training sessions
- Perform other related duties as assigned

Minimum Qualifications:

To perform this job successfully, an individual must be able to perform each essential duty* satisfactorily. The requirements listed below are representative of the knowledge, skills, and/or ability required:

Education and Experience:

Minimum age of 18 years old with a High School Diploma (or GED). At least 500 hours of experience in recreation with 15 units completed in recreation or a related field preferred, or an equivalent combination of education and experience.

Certificates and Licenses:

- Adult and Pediatric First Aid & CPR/AED
- > CA Driver's License and Proof of Insurance required if driving on behalf of the District

Additional Knowledge, Skills, and Abilities:

Ability to communicate effectively in English in both written and oral form. Ability to write routine correspondence using correct spelling and grammar. Ability to add, subtract, multiply, and divide in whole numbers, fractions, and decimals. Ability to apply common sense and exercise good judgement in solving problems. Ability to establish effective relationships with fellow employees, volunteers, and participants and/or parents/guardians.

Fingerprint-Based Background Check:

All recreation employees are required to obtain fingerprint-based background clearance at both the State (DOJ) and Federal (FBI) levels prior to their first day of employment.

Supervisory Responsibilities:

The employee may provide guidance or direction to other part-time employees and to volunteers.

Work Environment:

The work environment characteristics described here are representative of those an employee encounters while performing the essential functions of this job:

The noise level in the environment is moderate to loud. While performing the duties of this job, the employee is regularly exposed to outdoor weather conditions, including wet or humid conditions. The employee may occasionally be exposed to moving mechanical parts; high, precarious places; potentially hazardous chemicals or airborne particles; or risk of electrical shock. Exposure to hazardous conditions may vary according to Unit assignment.

Physical Demands:

The physical demands described here are representative of those that should be met by an employee to successfully perform the essential duties* of this job:

While performing the duties of this job, the employee is regularly required to sit, stand, or walk; use hands or fingers to touch, handle, or feel; use hands and arms to reach; climb or balance; stoop, kneel, crouch, or crawl; talk or hear; and taste or smell. Vision requirements include close, distance, color, and peripheral vision; depth perception; the ability to adjust focus; and the ability to see well in poor lighting or at night. The employee is regularly required to lift up to 10 pounds, frequently required to lift up to 25 pounds, and occasionally required to lift up to 50 pounds. Physical demands may vary according to Unit assignment. Day Camp employees are regularly required to hike up to five miles in a single workday.
