The Conejo Recreation and Park District recently purchased land for a future neighborhood park site.

The property is located south of the 101 Freeway between Rancho Road and Moorpark Road. The 2 residential lots, totaling 5.4 acres, are located in an unincorporated island within the City of Thousand Oaks between Rimrock Road and Rolling Oaks Drive.

The purchase price was \$975,000.

Raymi Schwartz of Pinnacle Estate Properties, Inc. represented the seller and buyer. Michelle Singerman of Ridgegate Escrow handled the escrow. Escrow closed on February 15, 2022.

The seller was the Goldfield Family Trust / Matt Goldfield. The sellers had owned the property since the early 1960's.

"The property has been in my family a long time.

My parents were going to build their dream home on those lots, but remained happily living in the family home in the Meadows Tract in Thousand Oaks.

When my parents passed away, we knew it was time to sell.

We were looking for a bit more money for the properties - - - but when I found out the Conejo Recreation and Park District wanted the property for a future park site, we made it work for them.

We're a huge baseball family and we know how important parks are to a community. I think my parents would be really happy knowing their dream home became a public park."

"We know the State of California is really pushing cities to add more housing and we expect the population of Thousand Oaks to grow. With that anticipated growth, CRPD is trying hard to maintain its parks/population ratio and a park system which allows everyone access to a park within a 10-minute walk from their home. There is currently no park south of the 101 freeway between Rancho Road and Moorpark, so all the folks living there now must travel under the 101 every time they go to a public park. In the future, this park will give them a public park within walking distance."

Board Members George Lange and Susan Holt sit on the District's ad hoc property acquisition committee and have been looking for land acquisition opportunities - - - focusing on locations that are (or may become) park deficient. This vacant land was listed for sale and the committee recommended the Board consider acquiring this property.

"Working with Matt and Raymi has been great.

The Board of Directors authorized staff to try to acquire this property on January 20, 2022, and we were able to clear all contingencies and close escrow in less than one month. We're so lucky to have longtime residents like Coach Matt Goldfield and the Goldfield Family offer flexibility on the price so we could afford to add a new park site to our system."

The vast majority of CRPD park property acquisitions have come through the development approval process --- Tract Maps and Development Agreements - - - which required the property owner/developer to dedicate land for public park purposes as part of the approval of residential development.

This is CRPD's first cash-based property acquisition in decades. For the past 30 years, CRPD has invested funds into capital improvement projects - - - creating public access and park improvements on all those vacant properties which had been dedicated for park purposes years earlier. According to CRPD records, the last time CRPD purchased park property with cash was El Parque de las Paz in 1986.

There are currently no plans for the property other than the notion that it is a really great location for a neighborhood park site. The property is next to a multi-family residential neighborhood, on the boundary between the City of Thousand Oaks and County of Ventura and will have some challenges around access. This is something CRPD must work on with the City and County -- as well as our immediate neighbors – the Rolling Oaks Homeowners Association and the Thousand Oaks Surgical Hospital, affiliated with the Los Robles Health System.

In the coming months, CPRD plans to host an open house, meet the neighbors, and get a sense of what they would like to see in their park. After we go through a robust public input and planning process, CRPD will then try to find the money necessary to complete those improvements.

The Conejo Recreation and Park District was established in November 1962 when Conejo Valley voters decided to create an Independent Special District focusing on parks and recreation (the focus on open space came a bit later). The CRPD park system now has over 60 parks and recreational facilities spread throughout the Conejo Valley. CRPD will be celebrating its 60<sup>th</sup> anniversary in November 2022.
