All applicable fire and safety controls must be in place. Permittee is responsible for any damage to CRPD property. If permittee is placing a temporary portable generator on District property, please see attached permit conditions. Contact Park Rangers at 805-402-9551 for entry into open space.

#### HOLD HARMLESS STATEMENT

The permittee agrees to indemnify and hold harmless CRPD and COSCA, their Directors, Officers, Agents, and Employees, from any and all losses, hazards, costs, charges, damages, professional fees, or other expenses or liabilities of every kind and character arising out of or relating to any and all claims, liens, demands, obligations, actions, proceedings or causes of action of every kind and character in connection with or arising directly or indirectly out of the activities conducted herein. Permittee shall provide a Certificate of Liability Insurance with a minimum of \$1,000,000 GL per occurrence and \$2,000,000 aggregate, and an Additional Insured Endorsement that names CRPD and COSCA, their Directors, Officers, Agents, and Employees as an additional insured.

Per the memo sent to all wireless providers on November 1, 2021, the following conditions must be met before temporary portable generators are placed on District property.

- 1. Regardless of circumstance (i.e., planned, and unplanned electrical outages), a provider must first gain approval from Conejo Recreation and Park District to locate temporary portable generators on District property. An encroachment permit form must be completed and the provider must describe the need for and duration of use of the equipment.
- 2. Conejo Recreation and Park District will specify the precise location on District property to place the temporary generator and path of travel to the selected location.
- 3. Following approval, for safety purposes, deployment and placement of the generator must include a locked temporary fence around the equipment for the duration of use.
- 4. Providers are responsible for cleanup of gas spills or leakage of equipment. Cleanups must be addressed immediately upon knowledge of the spills and before removal of equipment.
- 5. Removal of the temporary generator and fencing must be within 24 hours of end date indicated on the encroachment permit form.
- 6. The cost per day to place the generator on District property is \$50. Providers not obtaining prior approval and locating a portable generator on District property will be assessed \$75 per day, payable upon receipt of invoice.
